History of Sexual Misconduct of Clergy Serving in the Diocese of Joliet in Illinois 1949 – 1983 et seq.

Against the Diocese of Joliet.

The citations below are by no means an exhaustive list of the incidents of publicly reported sexual misconduct of clergy serving in the Diocese of Joliet. Some of the best evidence of this misconduct is contained in the internal files of the Diocese. The internal documents of the Diocese of Joliet are relevant as to what the Diocese knew or should have known about sexual misconduct of clergy serving in the Diocese.

1950's:

1958: Fr. James Janssen, a known pedophile, lives at the St. Isaac Jogues, Hinsdale, Illinois, Rectory while he is being treated for pedophilia at Loyola University Medical Center by Jesuit Psychiatrist, William Devlin, MD, SJ. During this time, Fr. Janssen is made Chaplain of the Boy Scout Troop at St. Isaac's, and sexually molests a boy of the parish. Letters between the boy and Janssen are presented to Fr. Henehan, pastor of St. Isaac's by the boy's mother. The letters between Fr. Janssen and the minor boy detail sexual misconduct in graphic detail. At the time Fr. Henehan receives these letters, he is an official of the Diocese of Joliet, a member of the Diocese of Joliet "Curia."

1988:

Fr. James Frederick serves in the Diocese of Joliet and faces "substantiated abuse allegations" while in ministry.

1969:

Fr. John Slown, Fr. Arno Dennerlein and Fr. Richard Ruffalo abuse brothers (John and Jeff Welch) at St. John the Baptist in Winfield. (Chicago Sun-Times, Ted Slowik, October 15, 2003, 'Joliet Brothers Sue Church, Urge it to Confront Abuse')

1972:

Fr. Myles P. White molests 13-year-old boy at St. Isaac Jogues Catholic Church in Hinsdale. Victim later commits suicide.

1970:

Fr. Donald O'Connor abuses an adolescent boy at Assumption Catholic Church in Coal City.

1968: Fr. John Barrett abuses boy at Notre Dame School in Clarendon Hills. (Chicago Sun-Times, May 8, 2002, 'Tearful Priest: 'I'm Innocent')

1968-

1973: Fr. Gary Berthiaume abuses 12 and 13-year-old brothers at Our Lady of Sorrows parish in Farmington Hills, Michigan. Case settles for \$35,000. Berthiaume also settles a case having been accused of sexually abusing four boys at a parish in Wyandotte, Michigan. Bishop Imesch admits at his deposition that he knew Berthiaume and knew about jail time that Berthiaume served for sexual misconduct - - before Bishop Imesch comes to Joliet, as its Bishop in 1979.

1970: Fr. Donald Pock sexually abuses George Knotek at the Divine Savior Parish in Downer's Grove.

1974: Fr. Phillip Dedera molests teenager at St. Andrew the Apostle in Romeoville.

- 1976: Fr. Phillip Dedera molests an altar boy (Tim Greco) at St. Pius X parish in Lombard. The boy is abused by Dedera over 100 times. (Chicago Sun-Times, May 3, 2006, 'Accused Naperville Pastor Proclaims Innocence')
- 1974-
- 1978: Acting together as a team, Fr. Jeffery Salwach and Fr. Harold Jochem jointly abuse a 7-year-old minor boy, a student at St. Jude Catholic Parish in New Lenox. That is, the two priests abuse this boy at the same time. This abuse continues for numerous years.

- 1978: Fr. Larry Mullins abuses George Fehrenbacher repeatedly at St. Raymond's Cathedral and Cathedral School. The abuse takes place in the sacristy, the school, the rectory and at the victims home. Later, Mullins would sexually abuse Fehrenbacher's brother, Christopher. Specific behavior by Mullins includes lewd fondling, masturbation and fellatio.

1975: Fr. Richard Bennett fondles an 11-year-old altar boy, Tim Greco, after mass at St. Pius X parish in Lombard.

1982: Fr. James Burnett repeatedly molests Dan Shanahan at St. Mary's in Mokena. The abuse occurs for approximately 4 years from 1978-1982.

1981: Fr. Myles P. White begins abusing John Roe at St. Boniface in Monee, in Illinois and at White's home in Culver, Indiana.

1978: Police arrest Fr. Gary Berthiaume for sexually abusing 12-year-old altar boy in Michigan. "Bishop Imesch knew that Gary Berthiaume, a priest of the Diocese, had admitted to and been convicted of molesting a child. Subsequently, Imesch assigned Berthiaume in the Joliet Diocese. Imesch has admitted that he did not report Berthuaume's admission of guilt to the police because "That's a job for the police. I'm not going to get involved in that. That's not my responsibility.""

1982: Fr. Michael Gibbney begins sexually abusing 11-year-old boy, Bobby Drish, at St. Francis of Assisi in Bolingbrook. The abuse lasts 2-3 years.

1978-

1979: Fr. Gibbney molests James Fonck at Mary Queen of Heaven parish in Elmhurst.

1978-

1980: Fr. Larry Mullins molests Christopher Fehrenbacher at St. Raymond's Cathedral in Joliet. Christopher is the younger brother of George Fehrenbacher, who Mullins also molested.

1979: Fr. Gibbs accused of abusing young boy. Bishop Imesch transfers Gibbs to another parish.

1980: Fr. "Thomas J. Roe" molests James Doe at St. Luke's Catholic Church in Carol Stream. The Priest allegedly exposes himself to the youth and fondles him in the parish rectory.

1979: Fr. Richard Ruffalo, a Diocese of Joliet priest, sexually abuses Tim Placher on a Las Vegas vacation. Although the boy had never been there before, the hotel bar where the two went knew the priest well. The two stay at Ruffalo's vacation home where he frequently took teen boys.

1987: Fr. Lawrence Mullins molests Brian Softcheck, James Oberg, and John Doe I, II, III. The abuse occurs when boys were between the ages of 9 and 13.

1980's:

- 1980: Fr. Lawrence Gibbs takes a dozen boys to a cabin at Wonder Lake in McHenry cabin and gives them alcohol. Gibbs makes the boys take off their clothes and parade around naked for him.

- 1981: Fr. Myles P. White strips off Jim Doe's pants in front of others. The priest then fondles the boy at St. Boniface Catholic Church in Monee. (Chicago Tribune, Jerry Shnay, August 17, 1993, '3 Suits Blame Diocese for Priests' Sex Abuse')
- 1980: Fr. Richard Ruffalo sexually abuses Jimmy Komp at St. Mary's in Park Forest.

- 1980: Fr. Frederick Lenczycki molests John Doe 87 at St. Isaac Jogues.

- 1983: Fr. John Slown sexually abuses a boy from the Diocese in a hot tub on a Las Vegas trip. Slown is defrocked and moves to Colorado.

In total, Lenzycki admits to molesting 13 males in Hinsdale and as many as 30 males in 6 parishes in three other states.

1986: Fr. Edward Stefanich is accused of sexually abusing a 14-year-old girl at St. Scholastica in Woodbridge. He is arrested and pleads guilty.

1980s: Fr. Anthony Meis is accused of sexual misconduct with minor at St. Mary and Joseph Parish in Chebanse.

1990 -

1992: Fr. Myles P. White engages in sexual activity with a 14 or 15-year-old boy. One incident is caught on videotape, which White mistakenly donates to a garage sale. White is arrested and charged in 1992 and serves 21 months in prison.

1990: Fr. Henry Slade sexually abuses an 18-year-old with Cerebral Palsy at the Parish Rectory of St. Isidore Catholic Church in Bloomington. Fr. Ross himself had sexually abused minor boys and had been sent away by the Diocese for treatment for such misconduct.
