That horrendous crime, through which States which have been polluted and sullied by it are consumed by the fire of God's terrible judgement, inflicts upon Us the bitterest pain, and heavily moves Our heart to bring as much effort as possible toward oppressing it.

§1. Clearly it is known to the Lateran Council that it has been established¹ that any Clerics who have been caught working in that wantonness which is against nature, for which God's wrath comes against the sons of faithlessness, must be cast out from the clergy or forced to lead a life of penance in the Monasteries.

§ 2. But lest the contagion of such a disease, through hope of impunity, which is the greatest enticement to sin, grow confidently stronger, We have concluded in council that the Clerical defendants of this nefarious crime must be punished severely, that for those who do not shudder at the damnation of their souls the avenging secular sword of civil laws may surely deter them.

§ 3. Therefore, we intend to pursue more fully now and with more vigor what we have already decreed about this matter at the beginning of our Pontificate, and we deprive any

Presbyter and any other Clerics, either *saeculares* or *regulares*, of whatever grade or rank, who commit so dire and unspeakable an act of all clerical privilege, and of every office, rank, and Ecclesiastic benefit by authority of the present canon. That those demoted by Ecclesiastic judge should be immediately delivered to secular power, and that among them he ought to receive the same punishment as those downgraded into the laity in this pestilence, is found to be established by legitimate sanctions.
